Release of Mineral Exploration Information

The Department of Mines, Industry Regulation and Safety (DMIRS), plans to release mineral exploration reports submitted by companies to DMRS under Section I ISA of the Mining Act 1978. Release of the reports is pursuant to Regulation 96(4), that is, where such statutory exploration reports have been held at the department for a period of five years or more. Reports proposed to be released were submitted to the department from January to December 2016.

Parsant to Regulation 96(6), the holder of a mining tenement covered by the report, or any subsequent tenement granted in renewal of an substitution for such mining tenement, may object to the release. Objections to the immediate release of a report must set out specific reasons why identified reports, or parts of reports, should not be released and must be received prior to the release of the report.

Also pursuant to Regulation 95(5) objections to the release of a report are only valid for a period not exceeding five years in each case. Therefore objections made between 2007 and 2017 to the release of reports submitted between 2002 and 2011 thave now lapsed and need to be renewed or the report wit be released.

Objections to the release of reports should be addressed to the Executive Director, Geological Survey and Resource Strategy Division, and emailed for sunsetclause@dmirs.wa.gov.au
