# Mingenew Turf Club:

To: President and Councillors of the Shire of Mingenew

I would like to address the question of approval being granted for the Mingenew Turf Club and the Mingenew Football club needing planning permission to erect our Shade Structure [extension of existing roof line] at the Mingenew Recreation Grounds

It has come to our attention that a motion has been passed that no planning approvals will be granted in the next 3 months.

Due to our very tight timeline and wanting the Shade structure erected before our next race meeting or we will once again have to outlay wasted money to hire a marquee, we would like council to make an exception in this case.

On our committee we have a registered Builder and a Fully qualified Builder and like most of our committee are Farmers. We only have a small window of opportunity to construct our shade structure, needing the project completed by the first week in September, prior to Harvest.

We are unable to obtain plans for our Shade Structure until a deposit is paid

We then need to give them to our Draftsman, who will then send them to his Engineer for Final approval prior to lodging with Council.

If there is to be no approvals given in the next 3 months, then it will be impossible for the Turf and Football clubs to go ahead with this project in 2024

We have been working towards this project for the last 3 years and will be extremely disappointed if after all our hard work, we must wait another year for a project that has no monetary constraints on Council.


The existing Turf club Bar area was jointly funded by the Mingenew Expo and Turf Club, since then The Turf Club have installed air conditioners in this area, and we also have positioned a cool room next to the building for Community use.






Hoping that Council looks favourably on our request and understand our time constraints in getting this Project to completion.


